4. Minutes of previous meeting of 7 June 2017 were duly signed as a true record.
5. Report on matters arising- Councillor Stannard confirmed the Dog Waste Bin has now been moved to near the new Footbridge on The Street. Clerk has advised Waveney Norse of the new location. Due to the Bee Orchids area not being cut it has allowed ragwort to grow and flower. Clerk will remove. The Chairman stated field gate did not work properly, another ditch will need clearing and there is some rubbish on the plots that look untidy. Clerk will assess condition of gate. Chair will consult with I Harris re hedge and ditch clearance and S Wilson re rubbish clearance.


