- 8. Pleasure Ground Rospa safety report. Councillors Spill and Stannard hope to action repairs to the Slide Tower, Suspended Log Walk, Wobble Board and Goal Posts over the Christmas break. Council considers the Pleasure Ground signage as sufficient (not an enclosed children's play area). Council agreed to delay base for picnic table until spring 2023 as ground now too wet. Review at February meeting. Councillor Williams raised concern over chickens on Pleasure Ground. Possible breach of current Defra Avian flu regulations. Chairman advised this is outside council's powers.
- Planning DC/22/3313/FUL. Temporary ground mounted solar photovoltaic (PV) farm with battery energy storage; along with continued agricultural use, ancillary infrastructure, security fencing, landscaping provision, ecological enhancements and associated works.
