- 5. Guest Speakers, Cllr Judy Cloke reiterated what had been written in her recent report (circulated previously) and in addition drew Council's attention to another planning application for a Solar Farm installation, this time at Flixton Airfield.
  Cllr Cloke also spoke about a recent meeting with Cllr Richard Rout SCC, on the topic of Devolution (proposal to have a regional Mayor) and the Local Authority Review (move to a unitary authority) about which Cllr Rout is an expert. Cllr Cloke is proposing that a similar meeting be arranged for the benefits of Parish Councils/Councillors also.

Cllr Anthony Speca, also reiterated what had been written in the East Suffolk Top Ten report (circulated previously).

- 6. Clerk's Report and Matters Arising:
  - 2025 Village Spring Clean thanks to Cllrs Evans and Willaims for their work in bringing about another successful Litter Pick for the Village. 10 bags of litter were collected and those taking part joined Cllrs Evans and Willaims at the Village HAll for tea and cake at the end of the event on Sunday. Debate was had as to whether or not another Litter Pick should be arranged for the Autumn. Decision deferred to September Council Meeting
  - Notice for circulation advising residents against placing obstructions outside of their property boundary (on the verge or highway), ready for circulation and on the website.
  - Sovereign Play Equipment Quote Clerk tried to ascertain how long the initial discount would be in place but was not able to get a definitive answer.
  - Suffolk Community Foundation support with funding replacement play equipment advised that they can assist with up to £3k for a single item or up to 30% for larger purchases.
